

Comparison of Funding By Shelter Size

The five member ACWS shelters range in size, the smallest shelter holding 14 fewer beds than the largest. The difference in funding based upon shelter size is not based upon a formula. In order to maintain the confidentiality of our member shelters, we are not listing any identifying information, such as the number of beds. The mean funding amount in this range is \$236,730.

RESOLUTION REGARDING ALBERTA COUNCIL OF WOMEN'S SHELTERS

WHEREAS the Chiefs of Treaty 6, 7, and 8 met at a Special Assembly on Health on March 16 & 17, 2005 at the Chateau Louis Hotel in Edmonton, Alberta; and

WHEREAS on reserve shelters are discriminated against in funding levels and salary levels; and

WHEREAS families look to their leaders in healing communities

THEREFORE BE IT RESOLVED THAT the Chiefs in Alberta recommend that:

- 1. Immediate action be taken to ensure parity for on-reserve shelters in Alberta with their Provincially funded counterparts by April 1, 2005 and that this initiative remain an ongoing commitment by the Government of Canada.
- 2. That an adequately funded on-reserve Shelter Program be established by January of 2006, which includes the crisis line, outreach, follow-up, safe visitation, second stage housing and public education.
